The interested parties may also inspect the auction materials before quoting their amount.

3. The vehicles will be sold on "as is where is basis" and no guarantee for its worthiness or quality will be given by this department.
4. The quotation should accompany the Earnest Money/Security Deposit @20% of the quoted amount in the form of Demand Draft/Banker's Cheque favouring Bongaigaon Municipality, any quotation without E.M/Security Deposit will be summarily rejected. The earnest money of the successful bidder will be released only after the deposit of the bid amount. Earnest money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid.
