

The details of Auctions notice may be obtained from the Office of the Bongaigaon Municipal Board from 16/08/2022 to 20/08/2022 during office hours. The interested parties may also inspect the auction materials before quoting their amount.
- 2. The auction notice is also available in the website www.bongaigaonmunicipalboard.in.
- The vehicles will be sold on "as is where is basis" and no guarantee for its worthiness or quality will be given by this department.
- 4. The quotation should accompany the Earnest Money/Security Deposit @20% of the bid value in the form of Demand Draft/Banker's Cheque favouring Bongaigaon Municipality. Any quotation without E.M/Security Deposit will be summarily rejected. The earnest money of the successful bidder will be released only after the deposit of the bid amount. Earnest money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid.
- Sealed quotation from person/firms interested in purchasing the above mentioned damaged items/scrap materials may submit their highest bid in a sealed cover addressed to "The Chairman, Bongaigaon Municipality" and will be received up to 02:00 PM on 20/08/2022 in the Office of the Bongaigaon Municipal Board" and will be opened at 03:00PM on the same day. - 6. The delivery of damaged items/scrap materials will be arranged only after the successful bidders submits documentary evidences in support of residential status (PAN Card, ID Proof etc in case of individual and Registration Certificate etc. in case of firms).
- 7. Successful bidders should remove the materials within 02 working days of depositing the bid amount in presence of BMB officials at their own expense.
- 8. This department will not owe any responsibility for transfer of vehicles and for any other liability for using these vehicles for commercial or any other purpose after sale.
